SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. On July 26, 2021 emails were sent out to our Faculty, Staff, and Confidential Employees inviting them to participate in meetings to discuss what went well during the 2020-21 school year, areas we need to improve for the 2021-22 school year and our APR. Each group was encouraged to email any questions, concerns, thoughts and/or ideas to the Superintendent by August 9th.

An invitation was posted on our website and social media platforms on August 2nd and a Global Connect Blackboard message was sent on August 4th to encourage all families to email the Superintendent a Zoom Webinar to discuss the points above.

A face to face meeting, held on August 11, 2021, took place with the Confidential staff and Superintendent to discuss the points above.

Zoom meetings were held on August 11, 2021 with the faculty, staff and community to discuss all questions, concerns, thoughts and/or ideas that were sent to the Superintendent about the points above.

We will continue to discuss ARP funds during each Board of Education meeting until the June of 2024.

We were 100% face to face last year for all 180 days. We will continue all current health and safety measures put into place during the 2021-22 school year. We will use these additional funds for:

- 3 year Maintenance Agreement with Mazza (Air Quality Systems)

- Update cleaning equipment and supplies

We will continue:

Daily disinfecting of the school and buses. Highly touched surfaces will be disinfected several times during the school day. Masks are required to be worn. We continue to take everyone's temperature at the doors before allowed to enter the building. Students will remain in their cohorts. Seating charts are required for all bus runs, including sports. Limit gang bathrooms to two people at a time. Encourage all teachers to be outside as much as possible.

We use a multiple data point evidence collection and then all aggregate data. This is followed up by Data Team Meetings, facilitated by our Principal and Director of Curriculum.

We use an effective RtI Tier system. All teachers have support for highly effective Tier 1 instruction with differentiation. Classroom teachers build in time to have individual or small group Tier 2 sessions during the day. Tier 3 intervention services are a pull out, one to one highly structured time with highly qualified teachers. We also offer after-school study hall. This is an hour after school when all 6-12 grade students can have a quiet place to work and have certified teachers support. We also have a half hour built in AIS to the Middle School and High School schedule.
